

It seems that Frederick's parents both died when he was just a young boy. His aunt and uncle, John and Jessie Sealey, took him and raised him and he took their surname "Sealey" as his own.

Frederick's attestation (enlistment) papers describe he as being 5' 2" tall, weighing 121 lbs, a machinist by trade and Church of England by faith. He enlisted at age 19 on November 17th, 1916. He was assigned to "C" Company of the Royal Newfoundland Regiment.


The following is the official service record hand written entries for Frederick:

- 1. 17 11 1916: Enlisted at St. John's
- 2. 31 11 1916: Embarked St. John's on the SS Florizel to Windsor, N.S.

3. 17 – 04 – 1917: Embarked Halifax onboard the SS Northland

- 4. 11 06 1917: Embarked for the BEF (British Expeditionary Force)
- 5. 12 06 1917: Disembarked Rouen, France
- 6. 08 07 1917: Joined unit in the field
- 7. 09 10 1917: Killed in Action near Langemark, Belgium

Pte. Sealey is commemorated on the bronze plaque directly below the Caribou at

Beaumont-Hamel (Newfoundland) Memorial in France.

Frederick is also commemorated on the Port de Grave Cenotaph, but his name is incorrectly inscribed as "J Seeley". Both the initial and the surname are wrong. Frederick Sealey was the only WW I Royal Newfoundland Regiment soldier from the area with that particular surname. J. Seeley does not exist
